| 1. | Murder | Telangana | Nalgonda | Mamillagudem (v) Mothe (m) | 21-11-00 | | 1 | Gangamma was raped and murdered by unknown dominant caste people. Police and goondas attacked and demolished the Dalit's houses. | Not known |
| 2. | Social Boycott | Telangana | Medak | Bellapur (v) Manur (m) | 07-12-00 | Dalits | | Dalits were boycotted by dominant caste people when they demanded the removal of dangerous, high-tension electric wire which was passing over Dalit houses.. | Demanded removal of high tension electric wire from above Dalits houses |
| 3. | Attack | Coastal | Krishna | Mukkollupadu(v) Nujiveedu (m) | 06-05-00 | 1 | 1 | MPTC member Veeramala Samrajyam and her husband, Balakrishna asked MLA Kotagiri Hanumantha Rao about housing during his Janachaitanya tours. The MLA abused them using their caste name. | Asked about Govt. housing programmes |
| 4. | Attack | Rayalaseema | Chittoor | Kograpalli (v) Chandragiri (m) | 22-01-00 | Dalits | | A dominant caste group led by Subramanyam Naidu, Ramachandra Naidu, Prabhakar, Maniratnam Naidu and Dhamamma attacked Dalit colony, beating residents and demolished their houses. | Not known |
| 5. | Attack | Rayalaseema | Chittoor | Anupalli (v) | 11-11-02 | Dalits | | Dominant caste Venkataswamy Reddy, Mohan Reddy and Gnanendar Reddy attacked Dalits and abused them, and fence was erected to restrict their movements. They ordered the Dalits to then leave the village. | Wanted Dalits to leave their colony |
| 6. | Death in Custody | Coastal | Krishna Kankipadu (m) | Proddutoor (v) | 19-03-03 | 1 | | Raju was taken in to custody over a house site case and beaten to death in judicial custody by police of Kanakipadu. | State violence |
| 7. | Seizure and Destruction of Property | Coastal | West Godavari | Kandellivaripeta (v) Achanta (m) | 27-02-00 | Dalits | | Dominant caste villagers set fire to the houses of the Dalit community. | Not known |
| 8. | Seizure and Property destruction | Coastal | West Godavari | Kuchipudi (v) Pedavegi (m) | 30-10-00 | Dalits | | Dalits occupied non-fertile land in the village and constructed their houses. Revenue officials identified the land as government land and hence agreed to issue pattas to the Dalits. But, dominant castes were unable to bear seeing the Dalits get land, and hence destroyed their houses. | Denial of land to Dalits |

| 9. | Seizure and Property destruction | Coastal | Visakhapatnam | Payakarao (v) | 10-11-00 | Dalits | | In Payakarao village near Thandava river, 90 families were residing on 7.72 acres of land belonging Panduranga temple for the past 30 years. In 1997, the Chief Minister ordered officials to give the Dalits pattas, but to date pattas have not been issued. But, some political leaders demolished 25 Dalit houses without notice whereas other dominant caste people are still living on the same land. | Denial of house-site to Dalits |
| 10. | Seizure and Destruction of Property by State Actors | Coastal | Krishna | Narasapuram (v) Vissannapet (m) | 13-11-99 | dalits | | Three hundred police and forest guards, led by District Forest Officer Sambhoji Rao, attacked Dalit colony, beating residents severely and causing serious injuries to nine Dalits, including three women and a 12-year old girl. They set fire 141 houses of Dalits. | Denial of housing |
| 11. | Seizure and Destruction of Property | Rayalaseema | Kurnool | Gospadu (v) | 23-01-00 | 1 | | Non-Dalit Venkateswarulu set fire to the house of Dalit Kottam Ratnamma . Dominant caste Reddies also imposed a social boycott on Dalit community and beat a Dalit boy who refused to play <i>dappu</i> (drum) for a dominant caste celebration. | Dalit refused to play <i>dappu</i> (drum) for dominant caste event |
| 12. | Seizure and Property destruction | Rayalaseema | Cuddapah | Rajupalem(v) B. Kodur(m) | 18-04-00 | Dalits | | Reddy caste people set fire to Dalits houses and attacked the Dalits as part of a plan to prevent Dalits constructing huts on government land allotted to them. | Attempt to deny house-site to dalits |
| 13. | Practice of Untouchability | Coastal | East Godavari | Komarajulanka (v) Ravulapalem (m) | 12-08-00 | Dalits | | Dominant caste Sakineti Somaraju warned 20 Dalits , who live in government-alloted houses, to vacate their houses. He abused the Dalit woman using their caste name. | To make Dalits vacate their houses |
| 14. | Practice of Untouchability | Rayalaseema | Kurnool | Nandipadu (v) Kolimigandla (m) | 23-05-00 | | 4 | Shathamma, Suvarthamma and Sugunamma had given money to the sarpanch to get them house pattas. When they asked for the house patta or return of the money, Musalanna and Balaiah abused them using their caste name. | House site |
| 15. | Practice of Untouchability | Telangana | Adilabad | Manchiyrala | 11-10-03 | | 1 | Suvarna a national-level athletic was given housing land. She constructed a house in that place. Non-dalits Bolisette Shankaraiah and 8 others abused her in caste name | Caste discrimination |
| 16. | Practice of Unotuchability | Telangana | Hyderabad | Hyderaguda | 06-11-01 | 1 | 1 | Lazarus of Hyderaguda was living in a rented house in Dominant Caste locality in Yerramanzil. Venkatamma (dominant caste), abused him using his caste name and harassed him to leave their colony. | Dalit residing in dominant caste colony |

He also insulted her by saying she was not supposed to sit in front of him and used filthy language with her. | Asked for permission to build govt. house for Dalits |
| 18. | Attack | Rayalaseema | Anantapur | Dharmavaram (v) | 23-01-03 | 1 | | Narayana was severely beaten with chappals by Samad, 25 th Ward Counselor for asking for the return of his money given for a house site. | Demanded return of his money |
| 19 | Attack | Rayalaseema | Cuddapah | Bakharapet (v) Siddipeta (m) | 21-02-01 | | 1 | Dominant caste Kada Subbaiah was using Subbama's house-site. When she asked Subbaiah to vacate the plot so she could construct a house, Subbaiah attacked her, beat her with chappals and abused her using her caste name. | Asked dominant caste to vacate her plot of land |
